Hable con un abogado de inmigración

Clínicas Virtuales de Consultas de Inmigración de Colorado (CO VICC)

¿Tiene preguntas sobre sus opciones de inmigración? ¿No está seguro de qué hacer? El *Immigration Response Group* puede conectarle con un abogado de inmigración con licencia para una consulta única que le ayude a comprender su situación específica.

¿Qué es esto?

Las Clínicas Virtuales de Consultas de Inmigración de Colorado (CO VICC) ofrecen citas virtuales, uno a uno, con un abogado de inmigración con licencia. Esta es una oportunidad para conversar sobre sus preguntas y recibir información clara sobre sus opciones. Las llamadas se realizarán en español o inglés. Si habla otro idioma, deberá llevar un intérprete a su cita.

Esto es solo una consulta.

No recibirá representación legal ni ayuda para llenar formularios.

¿Para quién es?

Residentes de Colorado que necesiten información legal confiable sobre inmigración y que no puedan encontrar o pagar una consulta con un abogado.

¿Cómo funciona?

- Se inscribe a través de una organización sin fines de lucro asociada
- Se reúne con el abogado de forma virtual (por Zoom o videollamada de WhatsApp) en tan solo 48 horas desde su reserva

¿Qué recibiré?

La oportunidad de hacer preguntas y recibir asesoría experta sobre sus opciones de inmigración. El abogado le ayudará a entender qué pasos podría seguir y le proporcionará recursos.

Cómo prepararse para su consulta:

- Escriba sus preguntas con anticipación
- Reúna todos los documentos importantes relacionados con su caso (avisos de inmigración, solicitudes anteriores, documentos judiciales o legales, etc.)
- Esté listo para hablar sobre su historial y objetivos migratorios
- Busque un lugar privado y tranquilo para su cita

Talk to an Immigration Attorney

Colorado Virtual Immigration Consult Clinics (CO VICC)

Have questions about your immigration options? Not sure what to do next?

The Immigration Response Group can connect you with a licensed immigration attorney for a one-time consultation to help you understand your specific situation.

What is this?

The Colorado Virtual Immigration Consult Clinics (CO VICC) offer virtual, one-on-one appointments with a licensed immigration attorney. This is a chance to talk through your questions and get clear information about your options. Calls will be provided in Spanish or English. If you speak another language, you will need to bring an interpreter to your call.

This is a consultation only.

You will *not* receive legal representation or help filling out forms.

Who is this for?

Colorado residents who need trusted legal information about immigration and can't find or afford to schedule a consultation with an attorney.

How does it work?

- You sign up through a Colorado Immigrant Rights Coalition team member
- You meet with the attorney virtually (by Zoom or WhatsApp Video) in as early as 48 hours from your booking

What will I get?

A chance to ask questions and get expert advice about your immigration options. The attorney will help you understand what steps you might take and provide resources.

How to prepare for your consult:

- Write down your questions ahead of time
- Gather all important documents related to your case (notices from immigration, past applications, court or legal documents, etc.)
- Be ready to talk about your immigration history and goals
- Find a private, quiet space for your appointment
